SUBMISSION CRITERIA

- 1. The "20 Years, 20 Artists" exhibition is open to all dentists entered on the Roll of the Ordre des dentistes du Québec, and to all dentistry students at McGill University, Université Laval and Université de Montréal.
- 2. Each artist may participate as an "exhibitor" or as a "donor."
 All "exhibitors" must claim their work at the end of the convention (see item 10).
 All "donors" will donate their work to the Foundation for the silent auction. Income tax receipts may be issued subject to certain conditions (see the registration form).
- 3. Any artist wishing to participate must e-mail a photo of the work he or she wishes to exhibit, along with the duly completed registration form, by the April 15, 2016 deadline.
- 4. Acceptable artwork includes paintings, watercolours, sculptures, photographs, jewellery and accessories. Each piece must be approved by the exhibition organizing committee. The committee reserves the right to refuse any piece that could be problematic in terms of transportation, display or installation (size, weight, fragility).
- 5. All paintings, watercolours and photographs must be framed and ready to hang from a wall hook, otherwise they will be refused at installation time. All jewellery and accessories must have a display case or stand that can be hung up or set on a table, otherwise they will be refused at installation time.
- 6. Each piece exhibited must be insured by the artist.
- **7.** The greatest possible care will be given to keep the pieces safe during the exhibition. However, the organizers (the Foundation) will not be held responsible for any damage to or loss or theft of any pieces.
- 8. The artist is responsible for transporting his or her artwork.
- 9. The pieces will be accepted and installed on the Saturday prior to the exhibition opening, i.e., May 28, 2016.
- 10. The pieces must be claimed at the end of the convention, i.e. on Tuesday, May 31, 2016, between 4:30 and 5 p.m. No pieces may be removed prior to the end of the exhibition.
- 11. Each artist participating in the exhibition authorizes the Foundation to use or reproduce his or her work for the purposes of advertising or providing information about the exhibition and the proceeds, in the form of posters or photographs, and agrees not to make any claim for damages or indemnification of any kind.
- **12.** Participation in the exhibition implies complete and unreserved acceptance of any other activity related to this event.

*Fair market value of the piece (FMV)

If a receipt is issued for a gift in kind (non-cash), it must specify the fair market value of the gift.

Generally, if the FMV of the piece is less than \$1,000, a member of the registered charity, or another individual, with sufficient knowledge of the piece may determine its value. If the FMV is expected to be more than \$1,000, we strongly recommend that the piece be appraised by a third party (that is, someone who is not associated with either the donor or the charity). If the piece is appraised, the name and address of the appraiser must be included on the official donation receipt.

Note that if an external appraisal is required (FMV over \$1,000), the artist will be responsible for the associated costs.
